### **X. DRESS CODE:**

*Riders in a police vehicle will be properly attired. Members of organized groups associated with or sponsored by the police department may wear approved uniforms. Civilians permitted to ride in police vehicles will wear dress clothes, such as slacks, shirt and tie for men, dress or dress slacks and a blouse for women. Articles of clothing such as blue jeans, T-shirts, sweat shirts, tennis shoes, and other articles of casual dress will not be permitted. Under no circumstances will anyone riding with a Terrell Police Officer in a police vehicle wear a "ball cap."*

If you are not properly dressed, your authorization will be revoked and you will not be allowed to participate.
